Lunch will be available on the grounds, with a cost of \$10.00 per person. A reservation form for lunch is available below.

Premium List Information/Entry Completion: Please ensure your entry form is completed in its entirety and legible. Please remember incomplete entry forms (no signature, incomplete dog information, test level entered, dates entered, etc.) may be returned to the sender and may cause a delay in accepting final entries. Test Entered – please ensure that you have circled which test level you want entered. Entry Fees – checks are payable to the ESSFTA E-mail address – please indicate your e-mail address at the bottom of the entry form. To expedite notifications, we attempt to utilize electronic communication as much as possible. Entry confirmations and running orders, as well as other possible hunt test information, will be disseminated by e-mail whenever possible.

In addition to the hunting test, the ESSFTA will also be offering an ESSFTA Working Dog Test on Saturday. Dogs that are entered in the hunt test will be judged at the same time as their hunt test run due to the possibilities of very hot weather. Dogs entered in the WD only will be run at the end of Junior. The entry fee for the WD test is \$25.00 per entry. Pheasant and/or chucker will be used for the WD test. The WD test entry form can be found on the next page.

From the Holiday Inn at Six Flags: Take I-44 east to exit 264 and take the ramp right for MO-109 and turn right onto MO-109. Go approximately 2.1 miles and turn left onto MO-W. Continue approximately 6.4 miles and turn right onto MO-30 W. Continue approximately 13 miles and turn left onto MO-Y. Continue approximately 1.2 miles and keep straight onto Old State Road WW. Bear right onto MO-WW and continue approximately 3 miles on MO-WW. Wil-Nor Hunt Club, 9298 State Road WW, will be on the left.
